Sworn in for her second term on Tuesday, May 12, 2015, Mayor Covington became University Park's first female African American Mayor on May 10, 2011. She was a Village Board Trustee starting in 2003. Mayor Covington has resided in the Village for about 20 years. An information technology expert with more than 32 years with the federal government; Mayor Covington is employed with the Veterans Administration as a Subject Matter Expert, for critically important global technology-related programs.



Mayor Jacqueline Goodall
City of Forest Heights, Maryland

Jacqueline Goodall is the current mayor of the Town of Forest Heights and has served for eight years as an elected official in the town. Under her leadership the town has moved to the forefront of sustainable practices and established itself as a green municipality. She works locally and nationally to bring awareness, to communicate, and to educate elected officials and the community of environmental requirements and responsibilities that they have, as well as highlighting environmental injustice.



City Manager John Titkanich
City of Cocoa, Florida

Mr. Titkanich is the City Manager for the City of Cocoa, Florida and he is a member of the American Institute of Certified Planners. Prior to being appointed City Manager in February 2013, John served as the City's Community Development Director for over eight years and he previously served as a Planner in both Land Development and Economic Development for the City of Orlando. John created the Office of Economic Development for the City of Cocoa in 2002.



Daniel Walsh, Director
New York City Office of Environmental Remediation

Daniel Walsh is the founding Director of the New York City Mayor's Office of Environmental Remediation (OER). In 2011, OER launched the New York City Voluntary Cleanup Program (VCP), the nation's first municipal brownfield cleanup program. In its first four years of operation, the VCP has enrolled over 300 projects, bringing new businesses, over 6,400 permanent new jobs and over 4,000 units of affordable housing to properties that were vacant for an average of almost 12 years.
